Background

Transparency International Kenya (TI-Kenya) is a not-for-profit organisation that exists to contribute to a transparent and corruption-free society. TI-Kenya is one of the autonomous chapters of the global Transparency International movement that is bound by a common vision of a corruption-free world. TI-Kenya is marking 25 years this year, having built extensive experience in governance work at the national and county levels.

TI-Kenya, under the Climate Governance Integrity Programme has been implementing projects geared at promoting transparency, accountability, integrity and anti-corruption safeguards in climate finance governance (CFG) both nationally and globally. The purpose is to increase the capacities of climate finance governance stakeholders to better engage, advocate and contribute to CFG policy development, implementation, oversight, and accountability in Kenya. As part of the Climate Governance Integrity Programme under the Waverley Street Foundation (WSF) project, TI-Kenya aims to enhance transparency, accountability, and integrity in climate finance governance.

About the project.

The Climate Governance Integrity Programme (CGIP), funded by the Waverley Street Foundation, aims to enhance transparency, accountability, and inclusivity in climate policymaking, improve oversight of climate-related actions, and ensure justice for victims of environmental crimes and corruption. The Climate Governance Project will be implemented by Transparency International Kenya in Homabay and Elgeyo

Marakwet Counties. The primary goal of the project is to safeguard climate funding by enabling local communities, civil society, and accountability agencies to monitor climate investments effectively. This aligns with the national goal of enhancing transparency and integrity in climate finance governance in Kenya. In the long term, the project aims to establish strong anti-corruption policies within climate change funds, ensuring equitable and efficient use of resources. The project's objectives include adopting climate action plans at the county and ward levels and increasing citizen participation in climate governance. The project will prioritize administrative of corruption and governance issues surrounding the utilization of climate finance.

Purpose of the Assignment:

Kenya's implementation of the Financing Locally Led Climate Action Programme (FLoCCA) is crucial for building local resilience against climate change impacts. However, corruption poses a significant threat to the effective allocation and utilization of climate finance resources. The purpose of this assignment is to conduct corruption risk assessments in Elgeyo Marakwet and Homabay Counties, focusing on the FLoCCA program, to identify vulnerabilities and propose mitigation measures.

Scope of Consultancy:

1. Review existing documentation related to the FLoCCA program in Elgeyo Marakwet and Homabay Counties, including project plans, financial records, and procurement processes.
2. Conduct interviews and focus group discussions with relevant stakeholders, including government officials, community representatives, and project beneficiaries, to gather insights into corruption risks and challenges.
3. Assess the governance structures and systems in place for managing FLoCCA funds, including the selection of benefiting community units, procurement procedures, and financial management practices.
4. Identify potential areas susceptible to corruption, such as conflicts of interest, lack of transparency in decision-making, and inadequate oversight mechanisms.
5. Analyze the findings to prioritize corruption risks and propose targeted mitigation measures, including policy recommendations, capacity-building interventions, and institutional reforms.
6. Present the assessment findings and proposed mitigation measures in validation forums with key stakeholders, seeking feedback and endorsement.
7. Prepare comprehensive reports documenting the assessment process, findings, and recommendations for improving transparency and accountability in the FLoCCA program.

4. Governance Assessment Report	An assessment of the governance structures and systems in place for managing FLoCCA funds, focusing on the selection of benefiting community units, procurement procedures, and financial management practices.	Within the first 40 days of the assignment.
5. Corruption Risk Identification Report	A detailed report identifying potential areas susceptible to corruption, including conflicts of interest, lack of transparency in decision-making, and inadequate oversight mechanisms.	Within the first 50 days of the assignment.

7. Validation Forum Presentation	A presentation of the assessment findings and proposed mitigation measures in validation forums with key stakeholders. This includes gathering feedback and seeking endorsement.	By the end of the assignment period.
8. Comprehensive Final Report	A final report documenting the entire assessment process, findings, and recommendations for improving transparency and accountability in the FLoCCA program. The report should also include an executive summary, methodology, detailed analysis, and annexes with supporting documents.	On the last day of the assignment.

- **Format:** All reports will be submitted in both hard copy and digital format (PDF and Word).

Duration: The assignment is expected to take 60 days.

Qualifications of the Consultant:

Candidates should possess the following qualifications;

1. A university degree in Governance, Public Administration, Law, or related fields.
2. At least seven years of relevant experience in conducting corruption risk assessments, preferably in the context of development projects.
3. Strong analytical skills and the ability to interpret complex data and information.
4. Excellent communication and interpersonal skills, with the ability to engage effectively with diverse stakeholders.
5. Knowledge of climate finance governance and familiarity with the FLoCCA program is desirable.

Submission of Bids:

Interested candidates should submit the following documents;

1. Expression of interest/cover letter outlining their suitability for the assignment.
2. Technical proposal detailing the approach and methodology for conducting the corruption risk assessments.
3. Curriculum vitae providing a full description of the applicant's profile and relevant experience.
4. Financial proposal containing time and cost estimates for delivering the services.
5. Current Tax Compliance Certificate
